## EMBALMING

Except in certain special cases, embalming is not required by law. However, embalming may be necessary, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for this service, such as direct cremation or immediate burial. Embalming is the disinfection and temporary chemical preservation of the remains by a licensed embalmer with the State of California.

• No one other than licensed embalmers, their assistants, funeral directors, undertakers, public officers in the discharge of their official duties, and attending physicians and their assistants are permitted to enter the preparation room or any room marked "Private" or "Authorized Personnel Only".

• Personal effects on the deceased at the time of death, or personal effects placed on the deceased for viewing purposes, will be buried or cremated with the deceased unless specifically requested to be returned. If you would like the personal effects of the deceased from the time of death (jewelry etc.), please ask for them, if not, we reserve the right to leave all effects with the body.
